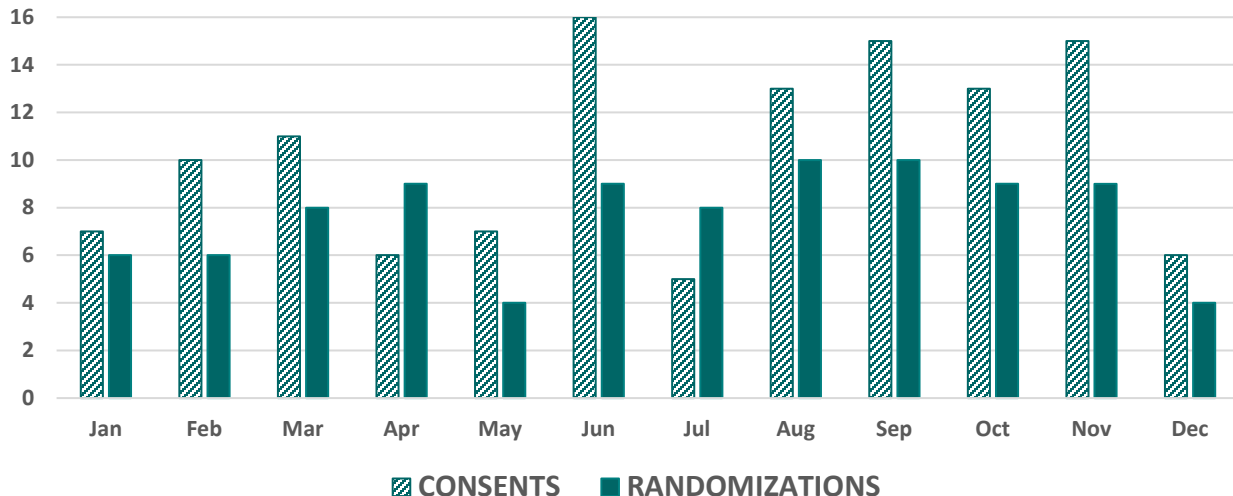

MAJOR CHANGES form Protocol v1.4

CHA₂DS₂VAS_C ≥ 2 removed as an eligibility requirement (section 4.2)

Change based on recent studies that show patients with ICH are at higher risk for thromboembolic events independent of factors reflected in the CHA₂DS₂VAS_C score. The score will continue to be collected at baseline and used (along with lobar/non-lobar location) as a stratification variable at randomization and for sub-group analysis.

Reimbursement for Subject Time (section 7.)*

Added reimbursement of \$50 for subject time for completion of study contacts (remotely or in-person) to acknowledge the effort required on their part. This will be in addition to reimbursement for travel-associated costs.

Provision of Home Blood Pressure Monitors (section 7.)*

HBPMs will be provided to sites to offer to subjects to facilitate BP assessment during remote contacts.

Provision of Pill Organizers (section 7.)*

Pill organizers will be provided to sites to offer to subjects to promote study drug adherence.

Prohibited Medications Revised (section 6.4)

Brings protocol into conformity with new list of prohibited medications that includes drugs other than anticoagulants and antiplatelets (i.e., combined P-gp and strong CYP3A4 inhibitors or inducers).

***REMINDER: You will not be able to implement Protocol v2 until your site-specific Informed Consent Document has been revised to reflect the changes marked with asterisk above and it has been approved by the cIRB.**
