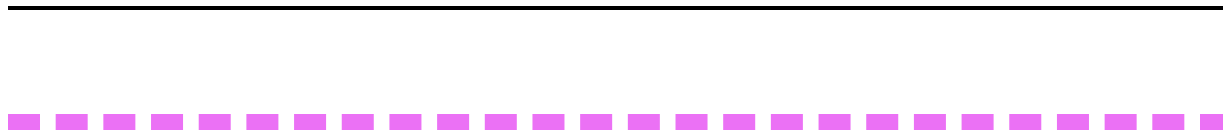


## Happy New Year to You and Yours!

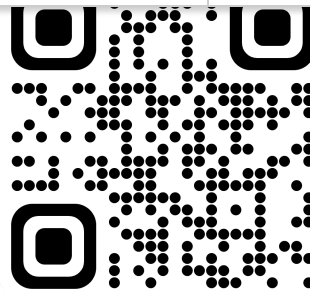
