Marking someone as Lost to Follow up (LTFU)

Emily Kaestner will email you once a subject is eligible to be marked as LTFU; this is 270 days post randomization.

Please respond to Emily if the visit was actually completed and data have just not been entered. You should not be moving a subject to LTFU before day 270 or without discussing with our team.

Update:

- o Removed Q10 'First/given name of reviewing site PI'
- o Removed Q11 'Last/family name of reviewing site PI'
- o Added Qd 'Reviewing site PI'

*Please note that Qd has a drop down that will include study team members that have ever had the site PI role on the DOA.

Who it affects: All F126 CRFs (including previously submitted forms)

Action:

- o Download and print off the new CRF for your paper source.
 - o Check for any open Rule Violations on F126 and address if you see one. (We were able to map most of the existing names to the full name under the new Qd. For ones that we were unable to map, a rule violation was triggered).
- *Rule violations can be accessed under the [Alerts] tab or by going to [Data Management], then [Rule Violation]. You can then use the 'Open Rule Violation' filter from the page Actions menu in the top right hand corner.
